

Spring Coaches Meeting Minutes - May, 27, 2020 Meeting held online via Zoom

1. Welcome

- a. Renee Drummond called the meeting to order at 3:35pm.

- 2. Financial Report
 - a. Peter Quinn delivered the financial report for the previous season (attached). The League's status is in a holding pattern currently, with the cushion of money we were able to freeze our losses from the lack of income from States and Districts. Certain items like some topics and trophies/medals can be repurposed in future seasons. Many schools have not completed payment for Borelli and District Congress, which is understandable given that most districts are not processing payments or purchase orders. Advisors and coaches were reminded to check with their districts to see what the plan is, and
- 3. COVID
 - a. Renee Drummond began the discussion by stating that the League intends to have tournaments run next school year, in some format.
 - b. Online tournaments seem to be the area to move forward in if physical tournaments are possible that is obviously preferable, but it seems unlikely that it will be possible in the near future.
 - c. There seems to be confusion as to the future statewide of stipend positions and funding given the economic situation.

- d. Jonathan Alston mentioned that the NSDA is working on their own online tournament platform and expressed hope that that will be ready soon and be affordable.
- e. Dave Yastremski shared a document discussed at the NDCA conference about legal, liability, and student protection issues surrounding online tournaments (live vs. recordings, conduct, permissions, use of materials, content, and copyright, etc.) The document included a list of best practices security, access, moderation, terms of use, abuse/bullying)
- f. Dave Yastremski and Amisha Mehta discussed online and physical tournament best practices that have been or could be successful in the near future.
- g. David Yastremski mentioned the possibility of running tournaments as a league NJSDL running tournaments in conjunction with "host" schools. Issues include purchasing liability insurance for the league, the cost of the online platform, judge payments and other judge considerations.
- h. Renee Drummond mentioned that this would require another meeting in late summer to see what the state of the pandemic is, the restrictions in place, etc. to decide next steps. In the meantime, leadership will consider scenarios and options and decide the operational and financial feasibility of our options.
- 4. Senior Recognition
 - Renee Drummond asked that coaches send in some form of recognition for senior team members – photos, blurbs, etc. – to be put on the website. Deadline is 6/5.
 - b. Cecilia Birge and Peter Quinn mentioned the online banquet ideas their teams are putting into place, as ideas for senior recognition for teams that are looking for ways to honor their senior members.
 - c. Andrew Prescott commented: "Just one final idea...but what if we ask our seniors across the league to either record a small video of what forensics means to me or a message to their fellow seniors? I feel awful they got that end of season experience stolen from them."
- 5. Online Tournament Experiences
 - a. Discussed under COVID agenda item.
- 6. Online Platforms
 - a. Discussed under COVID agenda item.
- 7. Concern/Statement about student-run camps/tournaments.
 - a. Dave Yastremski and Amisha Mehta mentioned the proliferation of these tournaments. As a League these are discouraged since no schools or organizing bodies are typically involved, and therefore liability and privacy issues are major concerns. Individual students are taking on the risk and responsibility themselves when they choose to
- 8. Committee Updates
 - a. Anne Poyner updated on the Judge Manual Committee. Dave Yastremski updated on the Judge Video Committee. Both indicated that a deadline of July 15 would be best to get everything finished by.

- b. Amisha Mehta updated on the Constitution Committee. Key items is succession of the President, splitting Outreach into Marketing and Schools.
- 9. Calendar
 - a. Renee Drummond mentioned that obviously the issue of the calendar is up in the air. She also mentioned the idea that this is the time to make any major changes to our program and offerings, given the unique opportunities presented. Radio Broadcasting was specific
 - b. Amish Mehta advocated for making open sessions available to new coaches so they can get a sense of how to get started and what happens at our team meetings and practices.
 - c. Mary Gormley mentioned that we may see more interpretation competitors as drama and theater productions are cancelled.
 - d. Malcolm Minor and Anne Poyner discussed the movement of interpretation (and Duo in particular) toward a more cinematic model due to the limitations placed on it and the recorded aspect of online tournaments.
 - e. Most major tournaments have committed to an online model at this point, including Newark Invitational here in New Jersey.

THE LAWYERS' PERSPECTIVE ON OUR ONLINE TOURNAMENTS...(NDCA Conference)

- 1. What platform should we be using?
- 2. What consent does the league (or its schools) need to obtain? How do we memorialize said consent?
- 3. What information is being recorded besides video? Chats? Files?
- 4. What can we limit to reduce the personal information footprint?
 - a. Live video?
- 5. Are we collecting and retaining the minimum level of personal information of students?
- 6. Are students and parents aware of the use and retention of personal information?
- 7. Is the use of personal identity limited to the intended purposes? Can't automatically use other video of marketing without consent.
- 8. If people, judges, competitors, observers misuse personal information, how is it handled? Who is responsible? School? Organization?
- 9. What is my personal liability as a tournament host?
- 10. Are students/parents aware of the relationship between schools, organizers, and online platforms?
- 11. Who has access to personal identity information? How available is it to the public? To competitors? To judges? To observers?
- 12. Are students/parents aware of the types of individuals/organizations who will have access to student's personal information?
- 13. Are rounds being transparently recorded (i.e., to prevent and investigate wrongdoing, to prevent harassment)
- 14. How do we handle copyright concerns? Use of evidence? Fair-use? Controversial case positions that students do not want 'out there'?
- 15. If judges find video helpful, how do we allow students to request 'no video' taking into the numerous considerations why they may not want to be recorded.
- 16. Are tournaments sponsored by league, schools, or individuals (there are lots of unauthorized tournament experiences and summer institutes out there. How do we let our students and parents know to be wary and ask the right questions?)

BEST PRACTICES

- 1. School district levels of classroom security (video conferencing, passwords, waiting rooms)
- 2. Restrict links, access control, and access management
- 3. Avoid reusing passwords for video
- 4. Covid phishing scams
- 5. Avoid suspicious links in Zoom chats
- 6. Update all operating systems, video software, and antivirus before competing.
- 7. Avoid open, public platforms (Youtube and twitch)
- 8. Review best practices with students.
- 9. Moderate comments/chats restrict when possible.
- 10. Clear, transparent, and memorialized Acceptable Use Policies and Terms of Service
- 11. Avenues to report abuse, cyberbullying, harassment, or misuse.
